**AN AMENDED ORDINANCE ESTABLISHING AUTHORIZED
MANPOWER FOR CALENDAR YEAR 2021**

WHEREAS, the original Ordinance was passed on December 14, 2020.

BELPRE, OHIO, THAT:**

SECTION I

The authorized manpower for calendar year 2021 is hereby amended, in accordance with the Schedule hereto attached as Exhibit A.

SECTION II

This Ordinance is declared to be an EMERGENCY measure, necessary for the immediate preservation of the public peace, health and welfare of the citizens of the City of Belpre, Ohio, and for the further reason that the first payroll is now due; wherefore, this amended Ordinance shall take effect and be in full force immediately upon its passage and approval by the Mayor.
