**RESOLUTION NO. 7 (2020-2021)**

**A RESOLUTION AUTHORIZING THE AUDITOR OF THE**  
**CITY OF BELPRE, OHIO TO ESTABLISH A SPECIAL**  
**REVENUE FEDERAL GRANT CORONAVIRUS**  
**RELIEF FUND PURSUANT TO OHIO HOUSE BILL**  
**481 AS AUTHORIZED UNDER OHIO REVISED CODE**  
**SECTION 5705.09**

**WHEREAS**, the Coronavirus Aid, Relief, and Economic Security Act, 116 Public Law 136, (the CARES Act) was signed into law by the President of the United States on March 27, 2020; and

**WHEREAS** the Ohio General Assembly has approved distribution of funds provided by the CARES Act in House Bill 481; and

**WHEREAS**, local governments are required to establish a separate Special Revenue Fund to account for and track activity of the CARES Act funds received and expended; and

**WHEREAS**, local governments have authority under Ohio Revised Code Section 5705.09 to establish the new fund without seeking the Ohio Auditor of State approval.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:**

**SECTION I**

The City Council of the City of Belpre, Ohio, hereby authorizes the Auditor to establish a Special Revenue Fund Federal Grant Coronavirus Relief Fund (2051) for the purpose of depositing revenue provided by the CARES Act used for expenditures with respect to the Coronavirus Disease 2019 (COVID-19).

**SECTION II**

This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and general welfare of the City of Belpre and, for more specific reasons, to be in compliance with the Ohio Office of Budget and Management (OBM). Wherefore, this Resolution shall take effect and be in full force from and immediately after its passage by Council and signing by the Mayor.
