**CITY OF BELPRE**  
**RESOLUTION NO. 32 (2016-17)**

**A RESOLUTION PROVIDING FOR A 1.75 MILL ADDITIONAL  
TAX LEVY FOR PROVISION OF FIRE AND EMERGENCY  
MEDICAL SERVICES FOR THE CITY OF BELPRE**

**WHEREAS, the City of Belpre passed RESOLUTION NO. 29 (2016-2017), and**

**WHEREAS, the City of Belpre has determined that RESOLUTION NO. 29 (2016-2017) must be AMENDED to reflect only one section of Ohio Revised Code §5705.19, and**

**WHEREAS, the Administration and Council for the City of Belpre have determined that the TEN MILL limitation on real estate taxes and the ONE PERCENT (1%) City Income Tax revenues are insufficient to provide proper resources for the provision of fire and emergency medical services for the citizens of the City of Belpre;**

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL  
OF THE CITY OF BELPRE, OHIO, THAT:**

**SECTION I**

**An Additional Tax Levy shall be levied against all real estate located in the City of Belpre that is not exempt from real estate taxes. The purpose of this Additional Tax Levy shall be to provide additional funding for fire and emergency medical services as provided in Ohio Revised Code §5705.19 (J).**

**SECTION II**

**This Additional Tax Levy on real estate shall provide for an additional levy of ONE AND THREE-QUARTERS (1.75) MILLS outside the TEN (10) MILL line taxation.**

**SECTION III**

**Said levy shall remain in effect for a FIVE (5) YEAR period. Said Additional Tax Levy shall be effective for the years of 2017, 2018, 2019, 2020 and 2021.**

**SECTION IV**

**Said Additional Tax Levy shall be presented for approval by electors for the City of Belpre as provided by law at the general election to be held on November 7, 2017.**
