# CITY OF BELPRE ORDINANCE NO. <u>20</u>

AN ORDINANCE APPROVING THE EDITION AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF BELPRE, OHIO

WHEREAS, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of the City of Belpre, Ohio; and

WHEREAS, numerous sections in the Traffic and General Offenses Codes need to be updated so as to conform to enactments of the General Assembly;
