ORDINANCE NO. 8

AN ORDINANCE APPROVING THE EDITION AND
INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE
VARIOUS COMPONENT CODES OF THE CODIFIED
ORDINANCES OF BELPRE, OHIO

WHEREAS, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of the City of Belpre, Ohio; and

WHEREAS, numerous sections in the Traffic and General Offenses Codes need to be updated so as to conform to enactments of the General Assembly;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL
OF THE CITY OF BELPRE, OHIO, AS FOLLOWS:

SECTION I
