AN ORDINANCE TO APPROVE THE FIRST AMENDMENT TO THE MASTER AGREEMENT TO PROVIDE SERVICES FOR THE CITY OF BELPRE ELECTRIC AGGREGATION PROGRAM

WHEREAS, pursuant to Chapter 4928 of the Ohio Revised Code, to facilitate competitive retail electric service to promote electric savings, lower cost of electric supplies, and other benefits, certain governmental entities may aggregate certain electric consumers within the jurisdiction; and

WHEREAS, on November 8, 2011, the electors of the City of Belpre approved of the City's plan to create an aggregation program for customers located within the boundaries of the City; and

WHEREAS, Revised Code 4928.20(C) requires a governmental entity interested in the automatic registration of customers under governmental aggregation, subject to customer rights to "opt-out" of such an aggregation, to adopt a plan of operation and governance for its aggregation program; and

WHEREAS, an original Master Agreement was adopted and approved by the Belpre City Council as Ordinance No. 6 (2012-13) on April 23, 2012; and

WHEREAS, a First Amendment to the Master Agreement needs to be approved and adopted by Belpre City Council;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

SECTION I

This Council hereby adopts and approves the First Amendment to the City of Belpre's Master Agreement to Provide Services, attached hereto for the implementation and administration of the City's municipal electric aggregation program in accordance with Ohio Revised Code 4928.20(C).
