The following is a Resolution enacted by the City of Belpre, Washington County, Ohio, hereinafter referred to as the Local Public Agency (LPA), in the matter of the stated described project.

SECTION I - Project Description

WHEREAS, the LPA/STATE has identified the need for the described project:

Bridge painting project on WAS SR 7 9.45 (SFN 8401500), WAS SR 7 9.47 (SFN 8401470) over CSX railroad tracks and WAS SR 7 9.78 (SFN 8400121), WAS SR 7 9.79 (SFN 8400091) over SR 7 exit ramp within the City of Belpre corporation boundary. Work includes painting of structural steel and minor repairs. Total length of work in the City of Belpre is approximately 0.13 miles.

NOW THEREFORE, be it ordained by the Council of the City of Belpre, (LPA)

Ohio.

SECTION II - Consent Statement

Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above described project.

SECTION III - Cooperation Statement

The LPA shall cooperate with the Director of Transportation in the above described project as follows:

The State shall assume and bear 100% of all of the costs of the improvement.

The LPA agrees to pay 100% of the cost of those features requested by the LPA which are determined by the State and Federal Highway Administration to be unnecessary for the Project.
