ORDINANCE NO. 2 (2014-15)

**AN ORDINANCE AMENDING CODIFIED FLOOD DAMAGE
REDUCTION ORDINANCE**

WHEREAS, the City of Belpre, Ohio, has an existing Flood Damage Reduction Ordinance, which is Chapter 1309 of the Codified Ordinances of the City of Belpre; and

WHEREAS, this City Council desires to amend Chapter 1309 of the Codified Ordinances of the City of Belpre, to update it and bring it into compliance with all current state and federal laws, rules, and regulations,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

SECTION I

Section 1309.02(19) of the Codified Ordinances of the City of Belpre, Ohio, is hereby amended to add a new subparagraph (D) to read as follows:

"1309.02(19)(D):
Individually listed on the inventory of historic places maintained by the City of Belpre's historic preservation program, which program is certified by the Ohio Historic Preservation Office."

SECTION II

Section 1309.02(21)(C) of the Codified Ordinances of the City of Belpre, Ohio, is hereby amended to read as follows:

"(C) Conditional Letter of Map Revision (CLOMR). A formal review and comment by FEMA as to whether a proposed project complies with the minimum National Flood Insurance Program floodplain management criteria. A CLOMR does not amend or revise effective Flood Insurance Rate Maps, Flood Boundary and Floodway Maps, or Flood Insurance Studies."

SECTION III

Existing Section 1309.02(21)(C) of the Codified Ordinances of the City of Belpre, Ohio, is hereby repealed.

SECTION IV

Section 1309.02(23) of the Codified Ordinances of the City of Belpre, Ohio, is hereby amended to read as follows:

"(23) Manufactured Home

A structure, transportable in one or more sections, which is built on a permanent chassis and is designed for use with or without a permanent foundation when connected to the required utilities. The term "manufactured home" does not include a "recreational vehicle". For the purposes of this chapter, a manufactured home includes manufactured homes and mobile homes as defined in Ohio R.C. Chapter 3781.06."

SECTION V

Existing Section 1309.02(23) of the Codified Ordinances of the City of Belpre, Ohio, is hereby repealed.

SECTION VI

Section 1309.03(i)(2) of the Codified Ordinances of the City of Belpre, Ohio, is hereby amended to read as follows:

"1309.03(i)(2)

Development activities in an existing or proposed manufactured home park that are under the authority of the Ohio Manufactured Home Commission and subject to the flood damage reduction provisions of the Ohio Administrative Code Section 4781."


SECTION VII

Existing Section 1309.03(i)(2) of the Codified Ordinances of the City of Belpre, Ohio, is hereby repealed.

SECTION VIII

This Ordinance shall take effect on the earliest date allowed by law.
