CITY OF BELPRE ORDINANCE NO. 3 (2014-15)

AN ORDINANCE TO APPROVE THE PLAN OF OPERATION AND GOVERNANCE FOR THE CITY OF BELPRE NATURAL GAS AGGREGATION PROGRAM

WHEREAS, pursuant to Chapter 4929 of the Ohio Revised Code, to facilitate competitive retail natural gas service to promote natural gas savings, lower cost of natural gas supplies, and other benefits, certain governmental entities may aggregate certain natural gas consumers within their jurisdiction; and

WHEREAS, on November 8, 2011, the electors of the City of Belpre approved the Municipality's plan to create an aggregation program for customers located within the boundaries of the City of Belpre; and

WHEREAS, Ohio Revised Code 4929.26(c) requires a governmental entity interested in the automatic registration of customers under governmental aggregation, subject to customers rights to "opt-out" of such an aggregation, to adopt a plan of operation and governance for its aggregation program;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

SECTION I

This City Council hereby adopts the City of Belpre's Plan of Operation and Governance (attached hereto and incorporated herein by reference as Exhibit A) for the implementation and administration of the Municipality's natural gas aggregation program in accordance with Ohio Revised Code 4929.26(c).

SECTION II

This Ordinance is hereby declared to be an emergency measure deemed necessary for the immediate preservation of the public health, safety and welfare of the City, and to allow the City's natural
