**A RESOLUTION APPROVING THE SOLID WASTE
MANAGEMENT PLAN FOR THE SOUTHEASTERN OHIO
JOINT SOLID WASTE MANAGEMENT DISTRICT**

WHEREAS, the City of Belpre, Ohio, is situated within the geographic boundaries of the Southeastern Ohio Joint Solid Waste Management District (the District); and

WHEREAS, the Policy Committee for the District adopted a draft Solid Waste Management Plan on May 9, 2016, for the fifteen (15) year period beginning in 2017 and ending in 2031; and

WHEREAS, the draft Solid Waste Management Plan for the District was submitted to Council for its review in accordance with the requirements of Chapters 343 and 3734 of the Ohio Revised Code;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL
OF THE CITY OF BELPRE, OHIO, THAT:**

SECTION I

The draft Solid Waste Management Plan for the Southeastern Ohio Joint Solid Waste Management District is hereby ratified.

SECTION II

A certified copy of this Resolution shall be mailed by the Clerk of the Belpre City Council to the District Coordinator at the District's Offices in Caldwell, Ohio.

SECTION III

This Resolution is hereby declared to be an emergency measure deemed necessary for the immediate preservation of the public health, safety and welfare of the City, and for the further reason that approval of this Plan must be timely communicated to the District Coordinator. Wherefore, this Resolution shall take effect and be in full force from and immediately after its passage by Council and signing by the Mayor.
