A RESOLUTION AUTHORIZING THE CITY OF BELPRE TO PARTICIPATE IN THE STATE OF OHIO COOPERATIVE PURCHASING PROGRAM

WHEREAS, effective March 6, 1986, Ohio's Cooperative Purchasing Act provides the opportunity for counties, townships, municipal corporations, regional transit authorities, regional airport authorities or port authorities and school districts, conservancy districts, township park districts and park districts and other authorities, to participate in contracts distributed by the State of Ohio, Department of Administrative Services, Office of Cooperative Purchasing, for the purchase of supplies, services, equipment and certain materials;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

SECTION I

The Safety-Service Director of the City of Belpre hereby requests authority in the name of the City of Belpre to participate in state contracts which the Department of Administrative Services, Office of State Purchasing, has entered into and the Office of Cooperative Purchasing has distributed for the purchase of supplies, services, equipment and certain other materials pursuant to Revised Code Section 125.04.

SECTION II

The Safety-Service Director is hereby authorized to agree in the name of the City of Belpre to be bound by all contract terms and conditions as the Department Of Administrative Services, Office of Cooperative Purchasing, prescribes. Such terms and conditions may include a reasonable annual membership fee to cover the administrative costs which the Department of Administrative Services incurs as a result of the City of Belpre's participation in the contract. Further, that the Safety-Service Director does hereby agree to be bound by all such terms and conditions and to not cause or assist in any way the misuse of such contracts or make contract disclosures to non-members of the Office of Cooperative Purchasing for the purpose of avoiding the requirements established by O.R.C. 125.04.
