**CITY OF BELPRE
RESOLUTION NO. 33 (2016-17)**

A RESOLUTION FINDING IT NECESSARY TO LEVY A TAX OUTSIDE THE 10-MILL LIMITATION AND REQUESTING THE COUNTY AUDITOR TO CERTIFY TO THE TAXING AUTHORITY THE TOTAL CURRENT TAX VALUATION OF THE CITY OF BELPRE AND THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY A 1.75 MILL ADDITIONAL LEVY

WHEREAS, the City of Belpre passed RESOLUTION NO. 30 (2016-2017), and

WHEREAS, the City of Belpre has determined that RESOLUTION NO. 29 (2016-2017) must be AMENDED to reflect only one section of Ohio Revised Code §5705.19, and

WHEREAS, the Administration and Council for the City of Belpre have determined that the TEN MIL limitation on real estate taxes and the ONE PERCENT (1%) City Income Tax revenues are insufficient to provide proper resources for the provision of fire and emergency medical services for the citizens of the City of Belpre;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

SECTION I

The City of Belpre, Ohio, has determined that it is necessary that an Additional Tax Levy be levied against all real estate located in the City of Belpre, Ohio, that is not exempt from real estate taxes, in order to provide additional funding for providing fire and emergency medical services as provided in Ohio Revised Code §5705.19 (J).

SECTION II

William D. McFarland, the Auditor of Washington County, Ohio, is hereby requested to determine the total current tax valuation for the City of Belpre, Ohio, and the dollar amount of revenue that would be generated by an Additional Tax Levy of 1.75 Mills.

SECTION III

Said Additional Tax Levy is to be presented for approval by the electors for the City of Belpre as provided by law at the general election to be held on November 7, 2017.
