ORDINANCE NO. 16 (2020-21)

AN ORDINANCE TO AMEND SECTIONS OF THE
GOLF CART ORDINANCE ADOPTED JUNE 28, 2021
AND TO AMEND OTHER EXISTING BELPRE
CODE OF ORDINANCES SECTION

WHEREAS, the Council of the City of Belpre adopted Ordinance No. 14 (2020-2021) requesting the use of golf carts upon the streets of the City of Belpre; and

WHEREAS, it has been determined by the Belpre City Police Department and the Belpre Safety-Service Director that certain amendments need to be made to enforce the provision of Ordinance No. 14 (2020-2021);

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

SECTION I

The Golf Cart Ordinance No. 14 (2020-2021) shall be amended to add a new Section IV in regard to Penalties:

SECTION IV: Whoever violates any section the Golf Cart Ordinance shall be deemed guilty of a minor misdemeanor. A person who violates this section for a second time within one year shall be deemed to have committed a third-degree misdemeanor.

SECTION II

Section III of the recently enacted Golf Cart Ordinance No. 14 (2020-2021) shall be amended as follows:

Section III. (6) Registered golf carts may be seized and impounded for violations of these rules and regulations.

Any unregistered golf cart operated on the Belpre City streets and highways may be seized and impounded at any time.

Any golf cart seized and impounded under these provisions is subject to all rules and regulations in effect for other impounded vehicles at the Belpre City Impound Lot.

SECTION III

This Ordinance is declared to be an EMERGENCY measure, necessary for the immediate preservation of the public peace, health and welfare of the citizens of the City of Belpre, Ohio; and further these amendments to the Golf Cart Ordinance and other Belpre Code Sections shall be an emergency due to potential immediate harm to property and persons and the general health and safety of the citizens of Belpre, Ohio; wherefore, this Ordinance shall take effect and be in full force immediately upon its passage and approval by the Mayor.
