ORDINANCE NO. 8 (2018-19)

**AN ORDINANCE APPROVING THE EDITION AND INCLUSION  
OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS  
COMPONENT CODES OF THE CODIFIED ORDINANCES OF  
BELPRE, OHIO**

WHEREAS, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of the City of Belpre, Ohio; and

WHEREAS, numerous sections in the Traffic and General Offenses Codes need to be updated so as to conform to enactments of the General Assembly;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

**SECTION I**

The editing, arrangement and numbering or renumbering of the ordinances and parts of ordinances of the City of Belpre are hereby approved as parts of the various component codes of the Codified Ordinances of Belpre, Ohio, as set forth in the 2018 Replacement Pages so as to conform to the classification and numbering system of the Codified Ordinances.
