**CITY OF BELPRE
ORDINANCE NO. _____ (2018-19)**

**AN ORDINANCE AUTHORIZING THE SAFETY SERVICE DIRECTOR
TO EXECUTE AN AGREEMENT INCREASING THE RATE FOR
COLLECTION OF GARBAGE, REFUSE AND HOUSEHOLD
RECYCLABLE MATERIALS WITHIN THE CITY FOR THE
BALANCE OF THE EXISTING CONTRACT FROM
JANUARY 1, 2019, THROUGH JUNE 30, 2020**

WHEREAS, Kimble Recycling & Disposal, Inc., an Ohio corporation (hereinafter referred to as "Kimble") and the City of Belpre, Ohio (hereinafter referred to as "City") entered into a contract for the collection and disposal within the City of garbage, refuse, and household recyclable materials with an effective date from July 1, 2015, through June 30, 2020; and

WHEREAS, Kimble has requested an amendment to the contract to increase the contract rate due to unforeseen market conditions that are negatively effecting the value of recyclable commodities world-wide; and

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL
OF THE CITY OF BELPRE, OHIO, THAT:**

SECTION I

The contract rate specified in the contract between Kimble and the City for the collection and disposal of garbage, refuse, and household recyclable materials within the City, which contract was authorized by City Council in Ordinance #15 (2014-15), passed on February 23, 2015, dated from July 1, 2015, through June 30, 2020, is hereby amended as follows:

Effective January 1, 2019, through the end of the contract on June 30, 2020, the contract rates are hereby increased by \$0.60 per unit per month. The effect of said increase will be that the monthly rate paid by City to Kimble shall increase for the balance of the term of the contract from \$38,574.00 per month to \$40,240.80 per month.

SECTION II

The Safety-Service Director is authorized to execute the agreement amending the existing contract between Kimble and the City to effect the changes set forth in Section I above.

SECTION III

This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, welfare and safety of the City, and for the further reason that immediate approval of this Agreement is necessary to continue the uninterrupted collection of garbage, refuse, and household recyclable materials within the

AMENDMENT TO AGREEMENT

WHEREAS the City of Belpre (hereinafter "City") and Kimble Recycling & Disposal, Inc. (hereinafter "Kimble") entered into an agreement for Kimble to collect and dispose of garbage, refuse and household recyclable materials for the effective date of July 1, 2015, through June 30, 2020; and

WHEREAS, Kimble has requested an amendment to this agreement increasing the contract rate from January 1, 2019, through June 30, 2020, due to unforeseen market conditions that are negatively effecting the value of recyclable commodities world-wide; and

WHEREAS, City Council of the City of Belpre has agreed to the increase in rate requested by Kimble; and

NOW, THEREFORE, the parties hereby agree to amend the contract for the collection of garbage, refuse and household recyclable materials for the period from January 1, 2019, through June 30, 2020, as follows:

Rates will be increased by \$0.60 per unit per month, which will result in the City payment to Kimble from \$38,574.00 per month to \$40,240.80 per month.
